

R package vignette for ImageMetrics: Analysis of images for social scientists

1 Introduction

In life and in politics, images matter. The nation’s first televised debate on September 26, 1960 fundamentally re-defined what it meant to be a political success in America—you needed to look presidential. It is now widely recognized that those who watched the debates on television saw a pale and underweight Nixon losing the debate to a calm and confident Kennedy, while the few who listened in via radio thought Nixon won. Images are just as important today: witness remarks by Harry Ried during the early stages of the Obama primary campaign, suggesting he was “impressed” by Obama’s light skin and lack of dialect. Shortly after, the Political Communication Lab at Stanford conducted a series of experimental studies, which found that viewing political advertisements with darker images of Obama had a negative impact on respondents’ preference for Obama as a presidential candidate during the early stages of the campaign (Iyengar et al., 2010).

The `ImageMetrics` package provides researchers with a number of useful tools for the study of images in social science. It allows researchers to import image data from `.jpg` and `.png` files (using the `png` and `ReadImages` packages), and to generate RGB and HSV readings for hand-selected portions of an image, which is useful when analyzing particular objects in an image such as a face. Though many GUI based image processing software packages such

as Photoshop allow users to get RGB and HSV metrics from a small range of pixels, this is the first package of which I am aware that allows the user to get these metrics from an object that is selected within an image. Furthermore, the fact that the package exists within the R environment means that saving the results of processing many different images is less susceptible to errors related to transcription.

Perhaps most useful for social scientists is the capability to generate HSV (Hue, Saturation, and Value (brightness)) metrics to describe each image or a particular portion of an image, which correspond respectively to the color, color intensity, and the lightness/darkness of an image. For example, in Messing et al. (2009), a similar approach was used to document that the 2008 McCain campaign used more images that portrayed Obama's skin complexion significantly darker in attack ads, and that both campaigns used images of their opponents with markedly low color saturation in attack advertisements. This vignette will document the process by which one goes about hand-selecting objects in images for analysis (e.g., faces) and how this package can be used to generate meaningful metrics with respect to the results.

2 Reading in Images

Reading in images is best done via the `readPNG()` function, part of package `png`. This function will read in a PNG file and return a three- or four-dimensional array representing each pixel of the original image, in red-blue-green (RGB) or red-blue-green-alpha (RGBA) format. The first two dimensions are the x and y coordinates of the image, while the third dimension represents each color "slice" of an image.

Users can access the actual pixel-by-pixel image data via `image@X`.

It is also possible to read in images using the `read.jpeg()` function, though it fails to read in some jpeg images.

If the image corpus in question is in a different format, it is relatively easy to use the powerful cross-platform application `ImageMagick` to convert a large batch of images from one type to another, available at <http://www.imagemagick.org/script/index.php>.

3 Hand-selecting objects in images

The `ImageMetrics` package provides a primitive but effective `tcltk` interface to allow users to selection a portion of an image for further analysis. In order to hand-select an object within an image, we need to represent the object as a polygon, with points corresponding to pixel locations in the original image. This can be done using the `setObjPoly` and `getObjPoly` functions. The former brings up a `tcltk` interface wherein the user clicks on various points to outline an object in the image. In the current implementation, no markers appear on screen telling the user where he or she has just clicked. Nonetheless, the system does record those pixels. The latter, `getObjPoly`, retrieves the points where the user selected, and converts them to approximate image coordinates. Here, C code from the `maps` package is utilized to quickly determine which points are within the polygon.


Figure 1: An image and object selected from it



When processing a large batch of images, users may find it more beneficial to go about creating these polygons in a corpus of images by utilizing the interface provided with `Bio7`, a Windows and Linux development environment originally designed for ecological modeling, available at <http://sourceforge.net/projects/bio7/>. `Bio7` provides an excellent interface with which one can outline a polygon in an image and send the image's coordinates to R. With a little bit of scripting, a system can be set up to easily extract the coordinates

from an image. For useful scripts and/or advice on setting up a system, please contact the package author [lastname] at stanford dot edu. This was the system used to gather polygons in Messing et al. (2009).

Future implementations will attempt to incorporate bindings for the `OpenCV` package for C++, which has facilities to automatically detect faces and other objects in images. When this capability is implemented, the `tcltk` interface will serve as a useful tool to develop training data sets for more complicated image and video processing tasks such as face delineation (post-detection) and expression classification.

4 Creating new images from selection

Next, users should use the `ObjSelect` function, which uses C code from the `maps` package to detect which pixels in the image are within the polygon that the user selected, and put the results in an `imageMatrix`. This function sets all pixels that are not located in the package to `NA`. Then, appropriate metrics can be extracted from the image or image selection. When the `plot` function is called on an S4 `imageMatrix` object, these `NA` pixels show up as black in the image. Writing the output to a file can currently only be accomplished by calling the `writePNG` function from the `png` package.

5 Generating metrics and density plots

The `ImageMetrics` package provides red-blue-green (RGB) and hue-saturation-value (HSV) metrics for an image or image selection. In the example below, we compare the brightness of a video still capture from MSNBC footage of Obama, with a still capture from an ad featuring the same footage that appeared in an ad on the Clinton campaign website. Obama appeared significantly darker and stretched horizontally in the Clinton ad, which exaggerated Obama's Afrocentric facial features. This caused quite a stir among Democrat bloggers, most notably "Troutnut," who accused the Clinton campaign of using racial bias as tool in attack advertising (Troutnut, 2008). Though the distortion may be a product of video software and/or compression, the racial sensitivities surrounding Obama's primary candidacy, along with the campaign's subsequent denial that they produced the ad (Fox, 2008) made the Clinton campaign appear clumsy at best.

The images in Figure 3 above show video stills that I captured from the Clinton campaign website and the original MSNBC footage (from YouTube). The package includes the polygons that correspond to the facial coordinates of Obama's face in each image `clintonpoly` and `msnbcpoly` respectively, so we simply create a new image from those coordinates, make sure the polygon is capturing the correct portion of the image via the `plot` function, and generate saturation and value readings.

We would also like the capability for storing image coordinates for later batch processing. We can create a data frame or list object with the image names and polygon coordinates.


It is also sometimes desirable to produce a density plot showing the distribution of pixels. Functions `svhist`, `huehist`, and `rgbhist` are built in to the `ImageMetrics` package produce plots showing the density of saturation and value, hue, and red-, green-, and blue- channel intensity in the `imageMatrix` object.

Based on the density plots of Obama's face in each ad, we can see that the Clinton ad is much darker and has significantly lower color saturation than does the original footage.

Furthermore, the image in the ad appears to have higher contrast, with tighter spikes at about .35 and 1 than in the original MSNBC footage.
